EXECUTIVE REPORTS

President - Janice Fendall

Good Afternoon Everyone. Thank you for coming to the CDCDA Spring General Meeting. A special welcome to members of the Edmonton Singles SD Club who are hosting the pizza party and charity dance after this meeting. I am Janice Fendall, President of the CDCDA. I would like to introduce you to the CDCDA executive who have been working very hard to make things happen in our dance community. Our treasurer – Carman, who submitted her resignation in Dec. 2022 but at the AGM in January, no one has stepped up to this job. I want to thank Carman for continuing as treasurer until we find someone. I again ask if anyone or if you know of anyone that would be interested in taking this on. We have a paid bookkeeper who is a great asset to this position. So between Carman as a mentor and Wade as the book keeper this position does not need to be as daunting as it might sound. Please consider.

I'd like to introduce John Younie who volunteered to be our secretary in January. John has stepped forward to take on a few extra duties and we have enjoyed having him as part of our zoom meetings. He has enjoyed being at the exec meetings as he does not have to record meeting minutes, due thanks to Tina, our admin assistant. I'd like to introduce our promo committee chair, Gary Smith. Our Federation Rep – Dwayne and Marian Jenkins. Our past president – Dave, Dance Event Committee Chair – Ella-Lynn, Members at Large – Sylvia, Mo and Eileen. Our EDCIA rep – Ken Sipe. Thank you to Tina, our Admin Support for all your help in supporting us with our bi-monthly email distribution, taking minutes at our meetings, and dealing with all enquiries that come thru the CDCDA website.

Over the past several months, the dance clubs have been busy with their weekly dances, ensuring their new dancers are having a great time and keep returning. Some have been having their themed dances and special dances and visiting other clubs. Just about "just like normal". Over the past several months, the CDCDA dance event committee and promotions committee have been busy scheduling our CDCDA sponsored dances, our summer dances, our national caller dance, and summer activities. Preparing advertising and brochures, keeping our FB page active and keeping the website up-to-date. I want to thank the clubs and callers who responded to the many enquiries for submission of club information and caller commitment so we can plan our activities. The CDCDA website has become a very important piece of social media used to promote our association and activities. Not only to keep our members informed but to ensure that new dancers interested in our dance community gets interesting and up-to-date information about us. Continue to use the website and your webpages.

Financial Reports - Carman Dufresne & Wade Garner

I am here today to supply an update on the financial activity for the first quarter of 2023. Wade has put the information together and it was and still is available on our website.

Generally January to March is a quieter time financially and especially so this year because Janice was away on holidays.

The first part of the handout refers to the Operating Account.

Bank Balance in Operating Account on March 31, 2023 was \$40,574.35 + \$1.59 in shares. We have a non-redeemable GIC of \$6,123.94 with accrued interest of \$144.71. It was reinvested in April 2022, for 17 months at 2.5% interest – matures Sept. 20, 2023. At that time it will be worth \$6,268.65.

Total in the Operating Account as of March 31 was \$46,844.59.

Everything is listed by dates: Some of our expenses appear each month.

- 1. Office space rent to Big Red at \$525
- 2. Honorarium for our Administration Assistant (varies).
- 3. Honorarium for our bookkeeper (varies).

Other expenses:

- 1. Financial Review for 2022 done by Big Red. \$467.25.
- 2. In past years, we purchased 10 extra CSRDS memberships to cover those who did not register before the October deadline. We did that this year and used those memberships BUT this year we had 3 clubs offer new dancer classes in January. We had 19 new dancers (Double Diamonds (7), Square Up (8), and Leduc Homesteaders (4)) so that brings our total members (336 plus 19) = 345 members in our division this year. So you will see income for CDCDA/CSRDS membership in Feb. and March and the payment of \$95 to ASRDF who forwarded the \$5 for each of the new dancers to cover 2023. There is no deduction for late memberships.
- 3. The other income came from Promenader advertising. (\$50)
- 4. We had a small amount we paid to Cassidy design for administrative work. We cannot take that part of what she does out of the casino account.

The Next section relates to the Casino Account.

Bank Balance in Casino Account on March 31 was \$73,494.81 +\$1.35 in shares.

Total in the Casino Account as of March 31 was \$73,496.16.

As in the other account, there are expenses that occur every month.

Cheerific – Website Maintenance (\$417),

Mail Chimp – twice monthly mail-out (\$16.60, \$19.14, \$19.18,)

ACN – Telephone and internet (\$102.89)

Other Expenses

- 1. Some clubs already received financial support last fall for the start up in the spring of 2022. Additional clubs have also applied. One more club was given assistance on February 1 and another received assistance in April. That one is not on this summary. There are more clubs that have submitted requests for financial assistance but have not yet been approved by the executive.
- 2. There was some expenses for our media promotional person Cassidy Design. \$67.73 paid Feb 26.
- 3. We posted an ad on Facebook January 20 \$36.67. Cassidy was covering this and we were paying her. Now it goes directly on our Mastercard.

The last section applies to the COTTLE Account

The Cottle Fund is a Saving Account. However there is \$8.25 in a chequing part of that account. In order to have that moved to the rest of the account, two executive members with signing authority must go to the credit union and make that request. So far we have not done that.

Bank Balance in the Cottle Account is \$4,769.24 plus common shares of \$1.24. Total of \$4,778.73

There has been no requests from this account so far this year. However, we have received interest in each of the three months.

Community League Intro Dances - In lieu of farmer markets this summer we are planning 5 or more INTRO dances at various Edmonton Community Leagues. We have received a good response and are working with the individual leagues to determine dates, dance form preference, and instructor availability. We believe having new people try our dance

forms will be more effective for recruitment. We also plan to target Stony/Spruce for two callers in that area, who are interested in starting a club.

Promotional Advertising- We will once again be using roadside Magnet signs to promote the two INTRO dances at WESAC (Square Dance and Choreographed Ballroom) and general promotion for the fall startup of our member clubs accepting new dancers. We are also planning to advertise in the Jubilations Dinner Theatre playbill, prior to our dance season startup.

We will be updating the web site and our fall startup brochure to reflect the new dance season. We are now collecting information from clubs offering new dance programs in the fall.

We welcome CDCDA members to join our committee, and we are always looking for fresh ideas!

- Memorial Notice Distribution A project started by Charlie and Rose D They have submitted 162 obituaries from old printed Promenaders to be posted on the website. They have created their own Dropbox file and an email address cdcda.memorials@shaw.ca to inform when a dancer /caller passes away. Charlie and Rose will manage their own database of email addresses. A message will go out in the mailchimp newsletter starting May 15th.
